Reference to General labelling criteria	Property	Requirements																																				
Clause 2	<i>Use(s)</i>	The criteria cover kitchen, bath and wardrobe cabinets as delivered from the supplier. The criteria cover all components which may be part of the installed cabinets.																																				
Clause 5.2	<i>Materials needed for completion</i>	<p>It should appear, whether the supplier prescribes the use of other materials at assembly and for completion, and whether these materials are included in the labelling license.</p> <p>Some products may need treatment before use or in the initial phase of the product's life span. If treatment of the product or other supplementary products are necessary or recommended by the manufacturer, it should be stated whether these products or treatments are included in the test.</p>																																				
Clause 6.5	<i>Sampling</i>	Unopened retail packages are sampled for testing whenever appropriate.																																				
Clause 7	<i>Reference room loading factor</i>	Surface areas [m <sup>2</sup> ] in the reference room appear below. Testing is carried out with cabinet fronts open exposing both the front and backside of the front.
